Chemical Resistance tested on B-787 printed with Series R6000 Halogen Free ribbon using the GlobalMark® printer. Samples laminated to aluminum panels and allowed to dwell 24 hours prior to testing. Test conducted at room temperature. Testing consisted of immersions in the specified test fluids for the stated durations. Immediately after removal from test fluid samples were rubbed 10 times with cotton swab saturated with test fluid. Results are the same without and with rub unless stated otherwise.
